# INAUGURATION OF THE EUROPEAN PLATFORM FOR ACCESS TO PERSONAL AND FAMILY RIGHTS (EPAPFR)

# **FEBRUARY** 19 AND 26, 2021 Online conferences

The EPAPFR (European Platform for Access to Personal and Family Rights in Europe) aims to contribute to the support of anyone facing difficulties relating to international private family law in Europe (EU) by promoting the coordination and cooperation of the legal and social systems established in the territory of the Member States, be they associative or institutional in nature.

This project is part of the European Union's Justice programme established for the period 2014-2020. The Justice programme finances actions with European added value that contribute to the further development of a European area of justice.

The EPAPFR project supports the implementation of European instruments and in particular Directive 2008/52/EC of 21 May 2008 on certain aspects of mediation in civil and commercial matters, the Succession Regulation of 4 July 2012, the Brussels II bis Regulation of 27 November 2003 in matrimonial matters, the Hague Convention of 19 October 1996 on parental responsibility and protection of children, the Council Regulation of 18 December 2008 on matters relating to maintenance obligations, the Rome III Regulation of 20 December 2010 establishing enhanced cooperation in matters of the law applicable to divorce and legal separation.

The project brings together several partners across Europe:

- The Research Centre in International Private Law of University Lyon 3 (CREDIP),
- The Belgian Association for the Law of Foreigners (ADDE),
- The International Social Service in Bulgaria (ISS),
- The University of Liège,
- The German Institute for Youth Human Services and Family Law (DIJUF),

- The Association of Women International Legal Information (FIJI), which carry out the project.

The project consists of linking access to rights services acting as close as possible to the beneficiaries in the following areas in the aim of facilitating effective access to justice or alternative dispute resolution, promoting the training of professionals and the information of beneficiaries, and encouraging the sharing of experience and information between institutional and associative actors in the various Member States.

Due to the health context, the colloquium for the inauguration of the European platform for access to EPAPFR rights will be held in the form of online conferences on 19 and 26 February 2021.
